The Quorum Court of Mississippi County, Arkansas, met in regular session at 6:00 p.m. in the Circuit Courtroom of the Osceola Courthouse with County Judge John Alan Nelson presiding. Following the Pledge of Allegiance, Justice Neil Burge gave the invocation.

Justice White moved to dispense with the reading of the minutes as copies had been provided to the members. Justice Ash seconded the motion and the voice vote was unanimous.

In the treasurer's report, County Treasurer Peggy Meatte reported the interest rate at 1st Commercial Bank in Blytheville was .55% on \$100,000.00 for one year. She reported the sales tax revenue was up for the month of February. She also stated county general funds were in great shape.

Committee Reports:

Energy and Property committee: Justice Ash reported the committee met on March 11, 2022. Topics of discussion were:

- Plumbing in bay area of the Blytheville Courthouse exposed to the weather. Cost to fix is \$9,800.00.
- Elevator inspection has not been done in Blytheville.
- Solution for bird problems in Osceola.
- Homeland Security system installed and request for payment has been received.
- \$250,000.00 grant received and requesting more funds from the ARP.
- Farmland update.

American Rescue Plan Committee: Justice McClanahan reported the committee met on March 11, 2022. Topics discussed were:

- City of Dell's request for assistance with their drainage problem (53,000.00).
- Renovations to both health departments (\$1,000,000.00 from the Revenue Replacement Fund)
- HVAC, hot water and ceiling repair in the big courtroom in the Osceola Courthouse (1.5 million from the Revenue Replacement Fund).
- Purchasing 16 cars for the Sheriff's Department out of the Revenue Replacement Funds \$650,000.00).

County Judge John Nelson asked the court to acknowledge receipt of the Joint Legislative Audit Report and he court did acknowledge receipt of.

- 4. Judge Nelson wanted to bring the insurance payments for the unpaid 2019 claims back in house. December 14, 2021 a zoom meeting was held with Dave Nichol. Nothing had been done. Justice Cullom said the county needed the EOB's, what had been paid, discounted and what the patient owed before claims could be paid. Might be settled for 60 cents on the dollar. Justice Cullom knew someone who could help with the claims. Justice Cullom thought the county should have gone to court instead of arbitration.

- 1. Meeting was called to order by Justice Reggie Cullom. Mr. Henry turned the meeting over to Justice Reggie Cullom and Mr. Nichol. Justice Cullom asked Mr. Nichol for the reason why there had not been more progress on the payments for the 2019 claims. A zoom meeting was held on December 14, 2021. No satisfactory resolution on the outstanding debts had been made. Mr. Nichol stated he had the signed settlements and the money was expected to be transferred to the trust and escrow accounts to pay the claims that had been discounted. Only 173 claims out of 1210 had been paid. Kelli Jones had a list of the number of claims paid from our office or Dave Nichol's office.
- 2. Mr. Nichol said he would send and updated claims list, color coded on settled claims and ones scheduled to be paid to the county on March 24, 2022. Judge Nelson told Mr. Nichol the county was not happy with the work he had been doing. Mr. Nichol said he was disappointed and had been working on it for two years and took a ton of effort. Mr. Nichol said he had been working with collection agencies to get employees off collections. No EOB's included.
- 3. Justice McDonald stated every day the county had employees, law enforcement, people with families going thru collections. Credit scores were being ruined, homes lost. The settlement of claims was urgent to the county and employees. Mr. Nichol said he had it in his other office and couldn't send today. Mr. Nichol thought it would be awhile before the rest of the claims were paid.
- 4. Meeting was set for March 30, 2022 at 1:30. Entire color coded list would be provided with claims paid thru the system. Justice Hepler asked if the second spreadsheet be sent on Tuesday for review before the meeting. Justice McClanahan asked if Mr. Nichol could find out a better time frame for settling the claims. Justice Mangat wanted Mr. Nichol to have information available to answer questions. Mr. Nichol disconnected.

- 1. Meeting was called to order by Justice Cecil McDonald. The committee met last year to discuss drainage fees that were being assessed. Meeting was turned over to Harley Bradley.
- 2. Mr. Bradley had been assessing since 1987, several years as a State auditor and became Assessor in 2000. Mr. Bradley was a certified reappraisal manager. Mr. Albritton was asked about the formula that was used to get the value of the taxes. Delinquent levee taxes were collected in the Collector's Office. Mr. Bradley was paid \$3,500.00 per year. Mr. Bradley suggested to come up with a formula and put in the system to be collected by the Collector. Rob Veach with the levee district liked the idea of combining the taxes. Could pay Mr. Bradley \$500.00 year. Randy Ferguson took over the drainage district when Mr. Albritton retired. Mr. Ferguson asked Mr. Bradley to take all the drainage districts and would be paid \$3,000.00 per year. Mr. Bradley's suggestion to correct the formula was to take what money was needed at the end and back into it. How much land and improvements and then you could figure a formula.
- 3. Jim Tompkins was the Assessor. Mr. Albritton was a drainage district supervisor. Randy Ferguson was a drainage district supervisor. There were 9 drainage districts. Bob Ramey stated the commissioners met once a year on big projects. Smaller contractors were used for smaller projects. \$1 million a year was spent on maintenance. Justice Burge stated the problem was not everything was not being taxed equally.
- 4. Property could have been improved because of the drainage ditches. Helped to determine the rate of tax. Each parcel was given a benefit assessment rate. There was not a standard rate across the board. Formula could be created on what taxes were collected last year.
- 5. Justice Ash asked before Mr. Bradley was hired who did the assessments for the drainage district. Mr. Albritton did the assessments prior to Mr. Bradley. Justice Ash suggested the drainage district figure what they had collected each year and what they wanted to move to for the coming year and work the formula out. Motion was made by Justice Betty Hepler to table for now. Second was made by Justice Justice Neil Burge. Motion passed.

6. Meeting adjourned.

- 2. All employees except law enforcement work and correction department work 40 hour work week. Anything over compensated at time and half. The normal work week for law enforcement (including jailers) and ambulance services shall be no more than 171 hours in a 28 consecutive day work period. Finance Department had to go back and look at two payrolls. Needed to change to 86 hours in a 14 day work cycle. Resolution was needed. Motion was made by Justice Betty Hepler to change to 86 hours in a 14 day work period. Second was made by Justice Cecil McDonald. Motion passed. Resolution would be presented to the Quorum Court.
- 3. Increase of mileage. The County went by the State guidelines. State went to .52 per mile. No changes needed. Letter attached.
- 4. Discussion Aaron Fleeman. State Law 14-14-1308. If a Quorum Court member did not attend meeting for 3 consecutive months without an excuse (illness, family illness, or something justifiable by the Quorum Court) the Court could declare a vacancy. Justice Fleeman had been called on meetings and had not returned some calls. Technically his seat was vacant. A vacancy had to be declared and sent to the Governor's Office notifying of the vacancy. Justice Ash thought it was not fair to the people in District #1. They didn't have a voice in the body. Justice McClanahan asked if anyone had contacted Justice Fleeman. Jacob Holmes stated Justice Fleeman had to be notified before the next Quorum Court to give him a chance to appeal within 30 days. Justice Jackson stated it was important to follow the guidelines. Justice McDonald also thought it was important to participate in meetings. A certified letter would be sent to Justice Fleeman to notify him to give him the option to resign. Meeting would be scheduled one week after green card was delivered. Mr. Holmes would notify the court when service was received.

Meeting was set for April 13, 2022 at 1:30. Peggy Meatte asked if the spreadsheet had been sent from Doctor's Health Group. Meeting was ended with Mr. Nichol.
- 3. Justice Cullom informed the Court he had someone available to oversee the payment of claims. They did not want a fee. Dr. Cullom called John Eddy who was in charge in insurance department for the Governor. Mr. Eddy knew the County had been dealing with Performance Health. Secretary for the Attorney General was interested in what was going on with the insurance claims. Performance Health had been in trouble in Mississippi. Judge Nelson prepared an e-mail to send to the Attorney General to protect others. Stephens didn't present Performance Health to the County. When claims were paid the committee would meet to discuss what would happen next year. The County should not be premium buying.

- 1. Meeting was called to order by Justice Michael White.
- 2. Adult Drug Court Appropriation. Judge Ritchey has asked for an appropriation for the Adult Drug Court. Stephanie Wofford was an officer of the court would like to do training. \$2,000.00 appropriation was needed for hotels, meals, etc. Money was available in the fund but not appropriated. Motion was made by Justice Molly Jackson to appropriate \$2,000.00 for the Adult Drug Court for training, hotels, meals, etc. Second was made by Justice Neil Burge. Motion passed.
- 3. Cash in lieu of benefits. Money was appropriated thru the month of April. Appropriation was needed for May. \$3,932.50 was needed for employee benefit program. Judge Nelson would speak with Mr. Holmes for an update at the Quorum Court meeting. Motion was made by Justice Burge to appropriate \$3,932.50 for the month of May. Second was made by Justice Harbans Mangat. Motion passed.
- 4. Sheriff cars. Money was appropriated for 6 new cars. Two cars would be replaced by insurance money. Total 8. Revenue Replacement Funds were to be used for an additional 10 cars. 18 cars out the revenue replacement funds. \$180,000.00 was appropriated to the Sheriff's budget. Justice Jackson thought the \$180,000.00 should be put back into County General and used for the State lobbyist. Motion was made by Justice Molly Jackson to zero the line item for \$180,000.00 and move the money to County General. Second was made by Justice Harbans Mangat. Motion passed.
- 5. Amend Appropriation Ordinance for the State Lobbying Firm. Money was appropriated out of revenue replacement fund. Ordinance needed to be amended at this months Quorum Court meeting. \$75,000.00 was appropriated and needed to be moved from RPF to County General for the State Lobbying Fund. Motion was made by Justice Neil Burge to amend the Ordinance and move \$75,000.00 from RPF to County General. Second was made by Justice Molly Jackson. Motion passed.
- 6. Appropriating funds for ARPA consultant. Two companies were interviewed. Appropriation was not needed. Some changes in the contract were made. Report due April 30, 2022. 30 days before payment was needed. Hourly rates varied. No more than \$200.00 an hour. Motion was made by Justice Molly Jackson to appropriate \$10,000.00 for the ARPA consultant from RPF fund. Second was made by Justice Harbans Mangat. Motion was passed.

- 7. Landfill Credit Card Acceptance Policy. Information was received and would continue to work on taking credit cards. Credit cards, debit cards, direct deposit were being looked at. Customers would pay fees instead of the county. Nothing needed at this time.
- 8. Clean up budget. Budget would be voted on for the 2021 budget.
- 9. JESAP. Every other year a JESAP evaluation was made. Salaries, benefits were compared to other counties. Comparables were based on job descriptions. Elected Officials needed to submit new job descriptions if needed. Best basis to request raises.
- 10. March expenditures. County General under \$8 million, Economic Development strong, county road fund \$2.3 million CD fund, \$3 million regular fund. Red gravel could not be hauled while raining. \$270,000.00 was received on a payment for the landfill. Courthouse budget was under budget.
- 11. Janice Currie and Leslie Mason's books were to be displayed in the new courthouse. Shelving for some of the books needed replacing and not in the budget. Judge Nelson stated there would be a delay on moving the furniture when courthouse was finished. Furniture company would need to be scheduled. Move back to the courthouse would not be as easy as leaving. Justice White was concerned about the jail operations fund.
- 12. Second payment for American Rescue Funds would be received in May. \$3.8 or \$3.9 million.
- 13. Leslie Mason needed a professional company to help move her office back to the new courthouse. Janice Currie said she believed Aaron Ruby would be building shelving for her office. Mrs. Currie needed to know where her files would be going and have some upright filing cabinets. Two would be needed. Leslie Mason offered her extra storage to whoever needed it. Judge Nelson asked Mrs. Currie if she could digitize her records. Originals were needed to certify.
- 14. When older books were scanned the books were cut and pages wrapped in brown paper. Two companies had been spoken with on preserving the books. When restored one book became two. Estimates would be received from the companies.

Melissa Prader East Area on Aging, Amanda Adams and Barbara Mitchell from the Senior Citizens Center. Confusion from the last meeting was explained. Funding was not discussed but the organizational structure of the Senior Citizens Center. Funding and financing were the Finance Committee and not Social Services.
- 2. The County had been acting as the sponsor of the Senior Citizens Center since 1976. East area on Aging was the pass thru agency for all State and Federal funding for these types of programs. East Arkansas had 12 counties. The agency found sponsors to be the administrative organizational structure. When a sponsor was not found the agency took it on.
- 3. Considerable cuts had been made thru the State and Federal Grants. Major funding cuts were because these programs were widely funded by a cigarette tax and less funding was available. They were also population based. Calculations were based on aging populations.
- 4. In 1976 the EOC was the sponsoring agency for the Miss. Co. Senior Citizens Center. Jo Floyd was the director at that time and did not think the EOC was the proper agency. Shug Banks was the County Judge. Judge Banks made the decision Mississippi County would be the sponsoring agent. There was no Resolution because the Quorum Court was restructured in January 1977. The Senior Citizens Center had been on the county budget since 1977. Contract was signed with East Area on Aging every year. The contract had been signed in the past by the Director. Contract in 2014 and 2015 was signed by Judge Randy Carney. RFP was done every four years from the East Area on Aging. Documentation had to be proved by the county to East Area on Aging regarding information requested.
- 5. Justice McClanahan had a letter from 2011 from the Senior Citizens Center acknowledging that the Miss. Co. Quorum Court was in favor and approved the Senior Citizens Center in Leachville could be moved to Manilla.
- 6. Justice McClanahan received a phone call from the State Auditor that stated. They didn't have any issues with the financing or record keeping with the Senior Citizens Center regarding Mississippi County and never had. Concerns over loosing funding over large contribution the county had given. East Area on Agency assured Justice McClanahan that was not the case.

- 7. East Area on Aging was a 501C3 not a State departmental organization. When a donor would like to support Senior Services in Miss. Co. by getting a tax deduction they can donate to the East Area on Aging and designate to only be spendable in Mississippi county.
- 8. East Area on Agency owned the building in Blytheville. Justice McClanahan and Justice White visited the center. Considerable amount of money had been put into the center. Ceilings had been lowered and helped with energy efficiency. AC upgrades had been made. Justice McClanahan thought the rent the county paid should remain.
- 9. Transfer amounts. When Judge Nelson was Finance chair the county was transferring around \$40,000.00 in 2010. Amount now was close to ¼ million. The budget only gave revenues and does not show funding or what the county transferred. 2014 County General transferred just over \$161,000.00. 2015 jumped to \$238,000.00 thru 2017. 2010 was a census year and population was lost.
- 10. Justice McClanahan though the director should not be signing the contracts but the County Judge. Contract for services between the East Area on Aging and sponsoring agency. Contract was voluntary and had a 90 cancellation notice.
- 11. Justice McClanahan handed out a Resolution she would like the court to adopt. Justice Burge asked if the other two counties subsidized the budgets for the centers. The answer was they did part of the budget. Services in other counties were cut if money was not available. Justice Burge thought it was a great program. EOC lost funding in the middle of last year and services were cut. Justice Ash recommended to send the Resolution to Jacob Holmes for him to look at. The County Judge should be the one signing the contract. Second was made by Justice Joe Lewis. Motion passed.
- 12. Justice Ash stated the committee was not looking at cutting funding. The committee was looking at how and why the department got started. Motion was made by Justice Rick Ash to lift the hold on the purchase of the vans for the Senior Citizens Center. Second was made by Justice Joe Lewis. Motion passed.
