16 architecture firm and construction consultant to aid in the process of the construction; and

18 **WHEREAS**, Clements & Associates is an architect firm of North Little Rock; and

20 **WHEREAS**, Brownlee & Mann Consulting, LLC is a construction consulting
21 firm out of Little Rock; and

23 **WHEREAS**, the Mississippi County Quorum Court has decided it is in the
24 County's best interests to hire these two companies to aid in the construction of said scale
25 house;

27 **NOW, THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF**
28 **MISSISSIPPI COUNTY, ARKANSAS:**

30 1. The Mississippi County Quorum Court hereby recommends the hiring of
31 Clements & Associates as architect and Brownlee & Mann, LLC as
32 construction manager for the construction of a new scale house at the
33 Mississippi County Landfill at a cost not to exceed \$500,000.00; and

5 *AN EMERGENCY ORDINANCE BANNING ALL CONSTRUCTION AND BUSINESS ACTIVITY*
6 *SURROUNDING USED TIRE COLLECTION CENTERS AND PROCESSING FACILITIES IN*
7 *THE UNINCORPORATED PARTS OF MISSISSIPPI COUNTY, ARKANSAS, AND FOR OTHER*
8 *PURPOSES*
9

10 WHEREAS, the Quorum Court of Mississippi County places great value on public
11 health and the environment of the County; and
12

13 WHEREAS, the Quorum Court of Mississippi County supports the work of providing
14 local legislation and permitting to provide for a safe and habitable county for its residents; and
15

16 WHEREAS, the dangers to the public health and the environment posed by used tire
17 collection centers and processing facilities outweigh the public benefit; and
18

19 WHEREAS, the Quorum Court of Mississippi County is hereby imposing a ban on all
20 construction and business activity surrounding used tire collection centers and/or processing
21 facilities in the unincorporated parts of Mississippi County; and
22

23 WHEREAS, the Mississippi County Landfill shall not be prohibited from its continued
24 and existing operations as a result of this Ordinance; and
25

26 NOW, THEREFORE, be it enacted by the Quorum Court of Mississippi County,
27 Arkansas, that:
28

29 SECTION 1: A ban on all construction and business activity surrounding used tire
30 collection centers and/or processing facilities in the unincorporated parts of Mississippi County,
31 Arkansas is hereby implemented.
32

33 SECTION 2: This Ordinance, being necessary for the health, safety, welfare, and
34 property for the citizens of Mississippi County shall be in full force and effect immediately from
35 and after its passage and approval and an emergency is hereby declared to exist.
