10 11 12	WHEREAS, the Quorum Court of Mississippi County places great value on public health and the environment of the County; and	
13 14 15	WHEREAS, the Quorum Court of Mississippi County supports the work of providing local legislation and permitting to provide for a safe and habitable county for its residents; and
